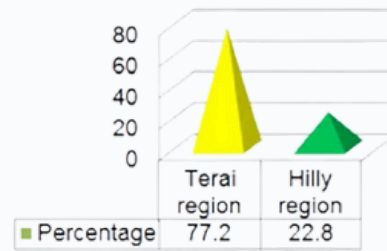

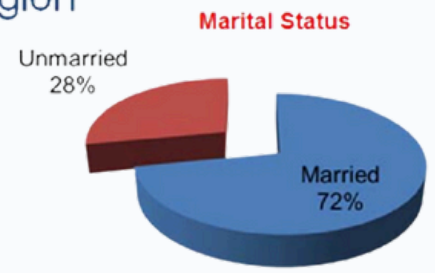

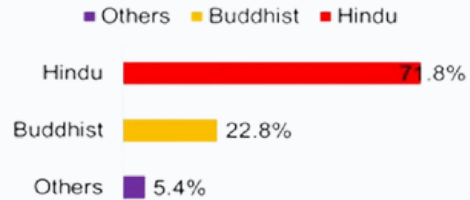
Distribution of population by location, marital status and religion
